MINUTES

1. CALL TO ORDER:

Mayor Eylar called the regular meeting to order at approximately 6:01pm.

2. VISITOR /PUBLIC INPUT:

Becky Billups spoke regarding her disappointment with the police department and concerns with the Council saying, "let's go for it", on hiring of the new chief and overlooking the lost opportunities for current city officers. Mayor Eylar offered a meeting, later, to discuss these concerns and Ms. Billups agreed.

3. DEPARTMENT REPORTS:

Public Works Department: Dennis Francis reported the sewer line collapse on Spokane Way prompting emergency work. Contractors are scheduled to begin emergency work April 17th. There is a small leak the O'Sullivan tank line due to Grant County PUD hitting the line. The City was unable to mark the line as the exact location is unknown. The department will follow up on this. Spring cleanup starts this week, and the department is working on street sweeping.

Fire Department: Chief Fish reported approximately 176 ambulance calls so far this year. The department is working on pricing for the new truck, and they will be helping the Tribe with a mock vehicle crash demonstration for the school.

<u>Police Department</u>: Officer Martin reported they have had an increase in calls, staffing levels are at two, and they recently updated the public records system to be able to send the records online. Also reported the Grant County Sherrif's office is willing to respond to high level emergencies, the prosecutor's office and MACC are aware of the staffing situation.

4. COMMITTEE REPORTS:

<u>Planning Committee: Update on City Parcels:</u> Councilwoman Dalton reported herself and Deputy Clerk Crowe have been working directly with the Grant County Assessor and the right-of-way parcels should not have district assessments and will be moved out of those categories and there are two parcels which do not appear to have the correct assessed values The committee is working with the assessor's office to have them reviewed potentially causing their removal from the categories and/or less cost to the City.
