ORDINANCE NO. 1099

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GRAND COULEE AMENDING ORDINANCE NO. 1089 TO INCREASE THE WAGES FOR AMBULANCE ATTENDANTS; INCLUDING A SEVERABILITY PROVISION AND SETTING AN EFFECTIVE DATE.

THE CITY COUNCIL OF THE CITY OF GRAND COULEE DO ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 1089, enacted December 20, 2022, which now reads:

Effective January 1, 2023, ambulance attendants shall be paid seventeen-dollars and seventy-six-cents per hour (\$17.76 per hour) with a minimum of one hour per call. In addition, each ambulance attendant shall be given a credit of \$2.00 per hour toward use of the Grand Coulee Ambulance Service for themselves or their immediate family. This credit may accumulate indefinitely but may not be converted into cash or any other benefit.

Is hereby AMENDED to read as follows:

Effective January 1, 2025, ambulance attendants shall be paid according to the scale below:

<u>Driver:</u> Non medically certified; Nineteen (\$19.00) dollars per hour with a minimum of one hour per call,

EMR: Nineteen dollars and fifty cents per hour (\$19.50) with a minimum of one hour per call,

EMT: Twenty dollars (\$20.00) per hour with a minimum of one hour per call,

In addition, each ambulance attendant shall be given a credit of \$2.00 per hour toward use of the Grand Coulee Ambulance Service for themselves or their immediate family. This credit may accumulate indefinitely but may not be converted into cash or any other benefit.

<u>Section 2</u>. Except as specifically amended as set forth in Section 1, above, the remainder of Ordinance No. 1089 remains in full force and effect.

<u>Section 3.</u> If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or the constitutionality of any other section sentence, clause or phrase of this Ordinance.

<u>Section 4.</u> This ordinance shall take effect January 1, 2025, after its passage, approval and a summary thereof consisting of the title is published.
