

RESOLUTION NO. 25-02

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRAND COULEE, WASHINGTON,
ESTABLISHING FEES RELATED TO WATER SERVICE.**

WHEREAS, the City Council passed Ordinance No. 1038, which Ordinance adopted comprehensive amendments to Chapter 13.04 of the Grand Coulee Municipal Code ("GCMC"), related to water service in the City; and

WHEREAS, the amendments to Chapter 13.04 GCMC require that most fees and charges related to water service be set by Resolution of the City Council; and

WHEREAS, the City Council now desires to pass this Resolution establishing fees and charges required by Chapter 13.04 GCMC related to water service;

NOW THEREFORE, the City Council of the City of Grand Coulee, Washington hereby resolves as follows:
Section 1. Pursuant to Chapter 13.04 of the Grand Coulee Municipal Code, the following fees are hereby established:
