RESOLUTION NO. 25-04

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRAND COULEE, WASHINGTON, ESTABLISHING FEES RELATED TO SEWER SERVICE.

WHEREAS, the City Council passed Ordinance No. 1046, which Ordinance adopted comprehensive amendments to Chapter 13.40 of the Grand Coulee Municipal Code ("GCMC"), related to sewer service in the City; and

WHEREAS, the amendments to Chapter 13.40 GCMC require that most fees and charges related to sewer service be set by Resolution of the City Council; and

WHEREAS, the City Council now desires to pass this Resolution establishing fees and charges required by Chapter 13.40 GCMC related to sewer service;

NOW THEREFORE, the City Council of the City of Grand Coulee, Washington hereby resolves as follows:

<u>Section 1</u>. Pursuant to Chapter 13.40 of the Grand Coulee Municipal Code, the following fees are hereby established:
